



Carbon Reduction Plan

Commitment to Achieving Net Zero

Bailie Group have signed the Race to Net Zero SME climate pledge to halve our scope 1 and scope 2 emissions by 2030 and achieve Net Zero by 2050. More information can be found here: https://smeclimatehub.org/

Our group wide carbon strategy is to drive reductions to Net Zero within our own operations and our value chain by 2050.

All entities within Bailie Group are committed to achieving the above targets.

In 2024, our fourth year of reporting we decided it was crucial to measure our entire scope 3 footprint. We chose to use 2023 as our baseline year for the additional emissions categories. This report includes the new 2023 baseline.

In Q1 2025 the Group structure changed. The Bailie Group has moved from a manager to an investor model with operating companies retaining full autonomy over operational decisions.

The Operating companies within the Group have each been given 3 objectives aligning with the triple bottom line of People, Planet & Profit.

- 1. Positive staff engagement
- 2. Agreed environmental commitments & plans including a carbon reduction plan
- 3. Delivery of agreed profit margins.

Bailie group will continue to invest for long term sustainable growth over short term gains.




Group Emissions - Baseline Reporting Year (2023)

As a parent company with only 7 FTE, Bailie Groups emissions are limited. However it is important to us that we are transparent about these emissions and work to reduce in line with our Net Zero objective.

Some of our original emissions calculations have changed since mapping our full footprint. Business travel now includes well to tank emissions.

We completed our baseline of the rest of our scope 3 in Q1 2025. We are now working on capturing these emissions for 2024 and will update this plan by year end 2025.



PlanetMark Certification 2024

The Bailie Group has been certified with The Planet Mark for the year ending December 2024 for reducing measured Scope 1 and 2 emissions (market-based) by a 17.9% absolute reduction compared to the previous year. This is across all operating companies within the Bailie Group.

Our Planetmark certification includes all of the categories of emissions reported here.
